

## How do I join?

- Marketing Executives (ME) and customers can enrol online at [FreeLife.com](http://FreeLife.com), or through one of FreeLife Distribution Centers (DCs).
- All MEs must agree to FreeLife International's Policies & Procedures. If you enrol online, agreeing to the policies is done electronically during enrolment. If you enrol through a DC, after having received your user and password you must log in to your back office account on [FreeLife.com](http://FreeLife.com) and click "I accept" where indicated for Policies and Procedures. For those enrolling by fax or mail, your signed ME Application will be sufficient.
- Marketing Executives must also submit the following in order to be eligible to earn commissions:
  - A copy of the front of the Hong Kong Identity Card (applies to Hong Kong MEs) must be mailed or faxed to FreeLife. Your ID card is privacy protected and is only used to protect against fraud and to ensure compliance with Hong Kong laws.
  - A completed US IRS W-8BEN form.
  - A completed Direct Deposit form (commissions are only paid by direct deposit).
- Marketing Executives must purchase an at-cost Business Kit (USD\$39.95) which includes:
  - Personalized website with online business tools that allows you to enrol Marketing Executives and market GoChi® and TAlslim.
  - Promotional materials and information to introduce you to FreeLife®

## How can I purchase product?

- In Hong Kong:
  - GoChi and TAlslim are sold in 1 case allotment (4 bottles). GoChi is also sold in a Value Pack allotment of 6 cases (24 bottles, special rules apply).
  - Purchases can be made online at [FreeLife.com](http://FreeLife.com), or through a Distribution Center.
  - FreeLife's convenient Advantage Customer Program (AC100) is also available and optional in Hong Kong. It offers automatic monthly shipments and the lowest available price. You can sign up for AC100 in the My Account area of your website, by phone, or by faxing or mailing a completed AC100 enrolment form to the location or numbers listed above.
  - Because the AC100 program is optional in Hong Kong everyone receives the Advantage price on all of their orders. Marketing Executives who have 100 points in personal volume (PV) each month will also qualify for the Fast Start Bonus and Product Rebate programs regardless of their enrolment status on the AC100 program.
- In Macau
  - GoChi sold in 1 case allotment (4 bottles).
  - Purchases can be made online at [FreeLife.com](http://FreeLife.com), or through a Distribution Center.

## Pricing

- Hong Kong
  - GoChi – AC price: \$161.95 USD (4 bottles).
  - GoChi Value Pack – AC price: \$809.75USD (6 cases or 24 bottles).
  - TAlslim – AC price: \$ 166.95 USD (4 bottles).
  - Price includes shipping/handling fees and applicable taxes.
  - If purchasing through a DC the DC sets the purchase price.
  - Value Packs may only be purchased by Marketing Executives during their first two months and there is a purchase limit of one (1) VP during this time period.
- Macau
  - GoChi – AC price: \$163.35 USD (4 bottles).
  - Price includes shipping/handling fees and applicable taxes.
  - If purchasing through a DC the DC sets the purchase price.

## Which payment methods can I use?

- Credit Card (Visa, MasterCard, Discover or American Express).
- DC's may offer additional payment methods. Please check with your local DC.

## How do I get my product?

- Orders placed on line will be delivered by the Importer. There is no pick-up option at this time.

## How do I get paid?

Direct Deposit is a quick, convenient and secure method for Marketing Executives in Hong Kong to receive their commissions. There are 2 ways to enrol for Direct Deposit:

- Enrol on line: Visit [FreeLife.com](http://FreeLife.com) and log in using your personal email address and password. Go to My Account, scroll down to Personal Profile, and select Direct Deposit. There you can fill out and submit the Direct Deposit enrolment form.
- Or you can visit the forms and documents link for your country in the Opportunity section of FreeLife.com; print a direct deposit form and fax or email it to FreeLife at the details above.
- Commission earnings must be at least \$5.00 USD to be released. If less than \$5.00 USD the commission will be held until the cumulative commission amount is at least \$5.00 USD.
- Commissions are not released until all documentation requirements are met. Once this happens all back commissions are released to the Marketing Executive in their next active commission period.

## How do I enrol others?

You may enrol anyone who meets the requirements to do business in your country or any other country where FreeLife does business in a number of ways:

- Sign up your prospect through the My Account section of your Freeliflife.com website.
- Send your prospect to your personalized freeliflife site where they can sign themselves up.
- Ask your prospect to call our friendly Customer Care department and sign up. Remember to give them your ID number!
- Ask your prospect to fill out a Marketing Executive Application and Agreement and fax or mail it to the details above.
